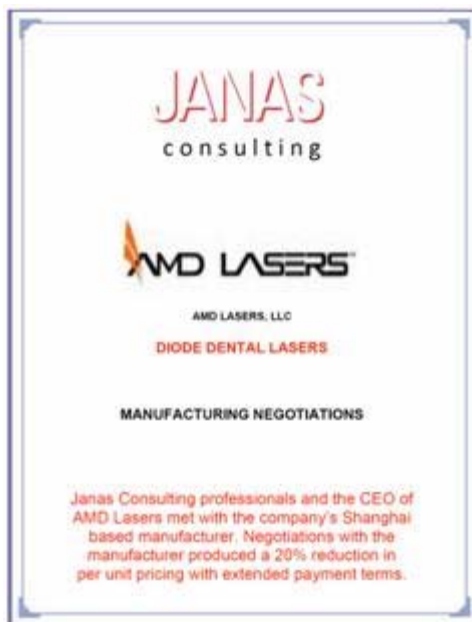

### NEGOTIATIONS FOR CLIENT IN CHINA

December 2, 2009



Carter Freeman and Kern Kwong traveled to Hong Kong and Shanghai to renegotiate our client's manufacturing agreement. Our client, [AMD Lasers](#), is a leader in soft tissue dental lasers. Carter and Kern met at the Hong Kong airport with two lawyers from Hui & Lam, a Hong Kong based law firm that they had recommended to the client. They met [Alan Miller](#), the CEO of AMD Lasers, in Shanghai to meet

with and renegotiate the relationship with the manufacturer.

In Shanghai, a new, comprehensive manufacturing agreement was completed that protected our client's interests by replacing the prior licensing agreement. We negotiated a 20% reduction in product pricing for product shipments that had been completed. In addition, an agreement was negotiated to extend payment terms. Our client's question to Carter and Kern was, "How did
